Section Wise

1. English Language

This section evaluates reading comprehension, vocabulary, grammar, and the ability to draw inferences from passages

Topic Area	What It Covers
Reading Comprehension	Passages from contemporary fiction, non-fiction, opinion pieces, and journalistic writing
Vocabulary in Context	Meaning of difficult words/phrases as used in the passage
Main Idea & Theme	Identifying the central argument or summary of a passage
Author's Tone & Viewpoint	Understanding the author's opinion, tone, and purpose of writing
Inference-Based Questions	Drawing logical conclusions that are implied but not directly stated
Grammar & Sentence Correction	Basic grammatical accuracy within the context of the passage
Arguments & Counter-Arguments	Identifying supporting and opposing arguments within a passage
Summarising & Paraphrasing	Choosing the most accurate summary of a given paragraph

Preparation tip: Reading editorials and opinion columns daily builds both vocabulary and the analytical reading speed this section rewards you

2. Current Affairs Including General Knowledge

This is the highest-weightage section in recent papers. It is entirely passage-based — you'll be given a news-style extract and asked to answer questions based on the facts and context within it.

Topic Area	What It Covers
National Affairs	Government policies, schemes, bills, and political developments
International Affairs	Global events, treaties, diplomatic relations, international bodies (UN, WTO, etc.)
Legal & Constitutional Developments	Landmark judgments, new laws, constitutional amendments
Economy & Business	Budget highlights, economic policies, financial news, RBI/SEBI updates
Awards, Honours & Appointments	National and international awards, key appointments
Sports	Major tournaments, records, sporting events
Science & Technology	Space missions (ISRO/NASA), AI and tech developments, environmental summits (COP series)
Books, Authors & Obituaries	Recently published books, notable personalities in the news
Static GK (contextual)	History, geography, and polity facts woven into current events

Preparation tip: Since this section is passage-based, memorising a static GK book alone won't help — pair daily newspaper reading with a monthly current affairs practice answering context-based questions.

3. Legal Reasoning

This is the section most unique to CLAT and carries one of the highest weightages. Your job is to apply principle to the facts and pick the most legally sound conclusion.

Topic Area	What It Covers
Constitutional Law	Preamble, Fundamental Rights, Fundamental Duties, Directive Principles, Citizenship, Centre-State relations, Amendments, Landmark Judgments

Law of Torts	Negligence, Strict & Absolute Liability, Vicarious Liability, Defamation, Nuisance, Trespass, Malicious Prosecution, general defences
Contract Law	Offer & Acceptance, Essentials of a Valid Contract, Consideration, Free Consent, Void & Voidable Agreements, Breach & Damages, Indemnity & Guarantee, Bailment
Criminal Law	General Principles (mens rea, actus reus), Culpable Homicide vs Murder, Theft, Robbery, Extortion, Kidnapping & Abduction, General Exceptions
Family Law	Marriage, Divorce, Maintenance, Custody, Succession & Inheritance basics
Legal Maxims & Terminology	Common Latin maxims used in judgments (e.g., volenti non fit injuria, res ipsa loquitur)
Public Policy & Contemporary Legal Issues	Environmental law, gender justice, consumer protection, recent Supreme Court rulings
Legal Ethics & Jurisprudence (basic)	Concepts of justice, equity, and the role of law in society

Preparation tip: Instead of memorising bare definitions, learn each principle through a real-world example — it helps you apply it faster to unfamiliar fact patterns in the exam.

4. Logical Reasoning

This section tests your ability to analyse an argument's structure rather than solve puzzles in isolation — it is passage/argument-based.

Topic Area	What It Covers
Critical Reasoning	Identifying arguments, premises, and conclusions in a passage
Assumptions	Spotting unstated assumptions behind an argument

Inferences	Drawing valid conclusions strictly from the given information
Strengthening/Weakening Arguments	Selecting statements that support or contradict an argument
Logical Consistency	Identifying contradictions or fallacies in reasoning
Analogies	Understanding relationships between concepts or situations
Cause and Effect	Distinguishing correlation from causation in given scenarios
Course of Action	Judging the most logical next step based on a given situation

Preparation tip: This section rewards precision over speed-reading tricks — practice identifying the exact conclusion an author is drawing before evaluating the answer options.

5. Quantitative techniques.

The smallest section by weightage, but often a scoring opportunity since the difficulty is capped at Class 10 level. It's built around data interpretation rather than pure calculation.

Data Interpretation	Bar Graphs, Pie Charts, Line Graphs, Tables, Mixed/Combined Data Sets
Percentages	Percentage change, increase/decrease-based problems
Ratio & Proportion	Comparative and proportional reasoning problems
Averages	Simple and weighted average-based questions
Profit, Loss & Discount	Basic commercial mathematics
Simple & Compound Interest	Interest calculation problems

Time, Speed & Distance	Basic motion-related word problems
Time & Work	Work-rate and efficiency-based problems
Mensuration	Basic area, perimeter, and volume calculations

Preparation tip: shift your focus from rote formulas memorisation to Data Interpretation and logical application.
